### **Tom Dykes Scholarship**

The Tom Dykes Scholarship can be granted to members in good standing and includes registration, lodging, travel and meals (not included in registration fee) for GPAG conferences. A maximum of two scholarships are offered at each GPAG conference. This scholarship was established for those whose agency will not pay for the member to attend GPAG conferences. In order to be eligible for this scholarship, member must write a letter requesting the scholarship and stating the reason for the need. The letter must be signed by the member's immediate supervisor and submitted to the GPAG Awards Committee Chair. Preference will be given to applicants that have not previously received the scholarship within the past two years.
